

The Gift Aid scheme – we can claim back 25p for every £1 you give!

Thinking of donating to St Boswells Village Hall? Here is a simple way of making your gift bigger, at no extra cost to you.

We can claim back 25p every time a tax-paying individual donates £1 to us, thanks to a government scheme called Gift Aid. St Boswells Village Hall is a charity (SC048481) and recognized as such for tax purposes, and we have registered with HMRC in order to take advantage of this scheme.

In the pages which follow you'll find three forms – one for one-off donations, another for multiple donations, and yet another if you wish to sponsor a specific event in aid of the hall. Just choose the one that's appropriate. These forms are Gift Aid Declarations, which give the Village Hall Management Committee permission to claim that additional money from HMRC. You will need to fill in our charity's name (St Boswells Village Hall, SC048481), together with your full name and address.

and he shall provide our bank details to enable you to make the transfer. In this case, the declaration form can be posted to the hall's address (as above) or scanned and sent to the treasurer's email address.

The treasurer would be very happy to talk with you about this highly advantageous scheme, which is easy to use and involves only a little paperwork. The village hall has been kept going by local support since 1896, and in the current challenging times we need your help more than ever.

For UK taxpayers, we recommend you use the Gift Aid scheme rather than our Paypal link.
